An ordinance levying taxes for all road purposes for LISLE TOWNSHIP ROAD DISTRICT, DuPage County, Illinois, for the tax year 2023, collectable in 2024.

BE IT ORDAINED by the Board of Trustees of LISLE TOWNSHIP, DuPage County, Illinois, as follows:

That the Highway Commissioner of LISLE TOWNSHIP ROAD DISTRICT on November 8,

2023, does hereby determine and declare that the sum of TWO MILLION THREE HUNDRED THOUSAND FORTY FIVE THOUSAND DOLLARS (\$2,345,000) is hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purposes as:

SECTION 5: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such finding shall not affect the validity of the remaining portion of this ordinance.

SECTION 6: That this ordinance shall be in full force and effect after its adoption, as provided by law.


