BE IT ORDAINED by the Board of Trustees of LISLE TOWNSHIP, DuPage County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of LISLE TOWNSHIP ROAD DISTRICT on December 11, 2024, does hereby determine and declare that the sum of ONE MILLION FOUR HUNDRED TWENTY FIVE THOUSAND DOLLARS (\$1,425,000) is hereby levied upon all property subject to taxation within the Road District as
