# LISLE TOWNSHIP ROAD DISTRICT

## 2025 ESTIMATED TAX LEVY ORDINANCE

An ordinance levying taxes for all road purposes for LISLE TOWNSHIP ROAD DISTRICT, DuPage County, Illinois, for the tax year 2025, collectable in 2026.

BE IT ORDAINED by the Board of Trustees of LISLE TOWNSHIP, DuPage County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of LISLE TOWNSHIP ROAD DISTRICT on November 18, 2025, does hereby determine and declare that the sum of TWO MILLION THREE HUNDRED THOUSAND DOLLARS (\$2,300,000) is hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purposes as:

- GENERAL ROAD FUND
- WORKERS COMPENSATION INSURANCE FUND
- ILLINOIS MUNICIPAL RETIREMENT FUND
- SOCIAL SECURITY FUND
- PERMANENT ROAD FUND
- EQUIPMENT & BUILDING FUND

for the year 2025.

SECTION 2: That the amount levied for each object and purpose shall be as follows:



SECTION 3: That the Town Clerk shall file with the County Clerk of said County of DuPage, on or before the last Tuesday of December, a duly certified copy of this ordinance.

SECTION 4: That the Board of Trustees does hereby certify that the amount levied herein is necessary to be raised by taxation for road purposes for LISLE TOWNSHIP ROAD DISTRICT.

SECTION 5: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such finding shall not affect the validity of the remaining portion of this ordinance.

SECTION 6: That this ordinance shall be in full force and effect after its adoption, as provided by law.
